

# REGISTRATION FOR TEAL HUNTING AT WACO LAKE

Please fill out the required information below in [Sections A & B](#) and return it to the Waco Lake Office. Applications will be due no later than August 23, 2010. **All registration forms must be received by 4:30 pm on August 23 to be eligible for the drawing.** Each hunter must show proof of Hunter Safety Education Certificate, upcoming season Hunting License including State Migratory Game Bird Stamp, Federal Migratory Bird Stamp and sign a Liability Waver. You may only hunt on the dates and in the areas listed on your permit. **No registered hunter may be listed on more than one application as hunter or guest.** All guest information must be completed prior to the submittal of this application. Children under 12 years of age may accompany an adult, but may NOT hunt. Copies of this information will not be made at the Corps Office. If you have any questions, call 254-756-5359.
